Campaign to Protect our Country Parks

We are writing to you on behalf of the Nottinghamshire Branch of UNISON, Britain's biggest public sector trade union, and our members who work at the country parks throughout Nottinghamshire, such as Bestwood, Sherwood and Rufford. These and many other green areas are managed by County Council employees, providing a wide range of leisure and educational activities, protecting the environment and maintaining a unique part of the county's heritage. The pleasure these parks and green spaces have given to the million plus who visit them every year is immeasurable.

However, their existence is under threat. Notts County Council claims it has to cut £186 million from its budget over the next four years. They plan to make over three thousand County Council employees redundant – a huge blow not only to those individuals who stand to lose their livelihood, but to the services they provide and to the Nottinghamshire economy as a whole.

The country parks' budget is being particularly badly affected. Amongst the County Council's proposals for the future of this service are:

- A cut of 47%, nearly half, of the current budget
- The abolition of the park rangers' service entirely
- Their replacement with a reduced number of unskilled park wardens

The implications of these cuts will be devastating if allowed to go ahead. Many of the activities at the parks will simply have to end. Health and safety will be greatly compromised, and an increase in anti-social behaviour is inevitable with such vastly reduced staffing levels. Staff who work at the parks have queried whether or not the council will even manage to meet basic legal obligations in some areas. Workers at Bestwood Country Park have told us that the Council's proposed axing of the budget will mean that Bestwood will effectively be "mothballed".

The claim that the Council has no option other than to make these cuts is simply not true. Notts County Council is sitting on £159 million of reserves, yet it refuses to use any of this money to protect the people it claims to represent from the most vicious public sector cuts Nottinghamshire has ever seen.

Thanks to the people who work at the country parks and their supporters in the community, the threat posed by the Council's budget proposals has been brought to the public's attention. We want councillors to re-consider their budget proposals, and we want your continued help to achieve this.

- Write to your local newspaper. Papers such as the Nottingham Evening Post have already featured articles about the proposed cuts at the parks.
- Come to the demonstration UNISON is planning on 24 February to coincide with the council meeting which sets the budget for the next financial year (please see attached leaflet). Further details will be available nearer the time from the Notts UNISON website (see header).
